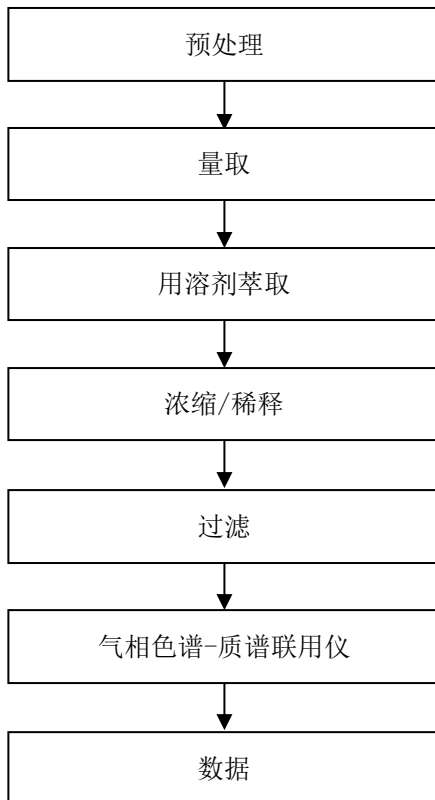

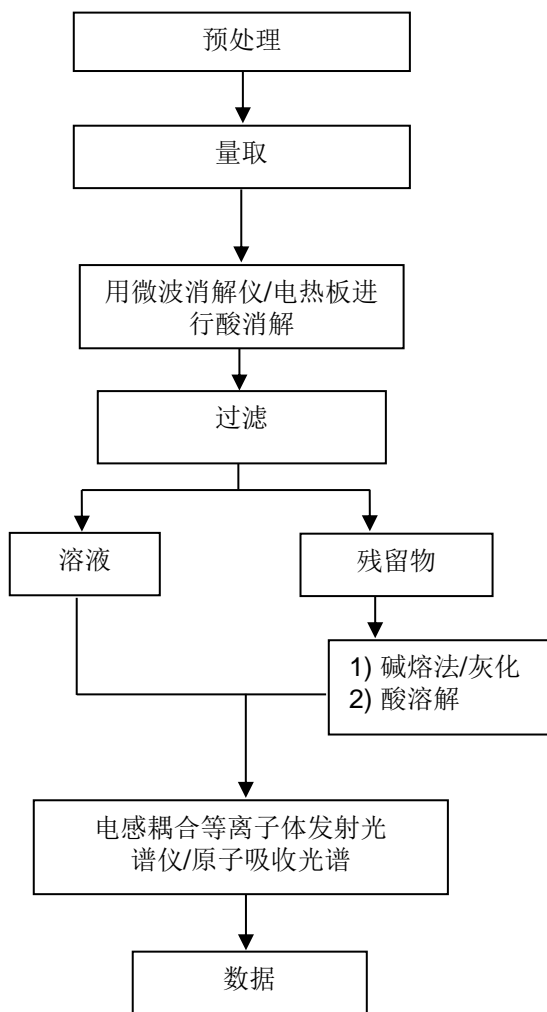

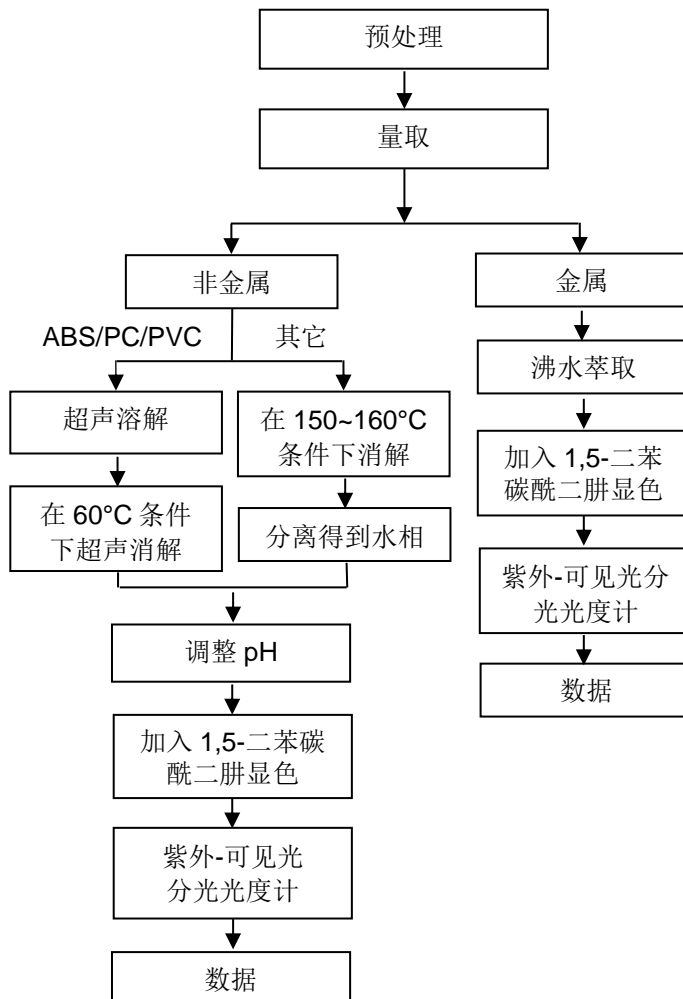

### 六价铬检测流程图

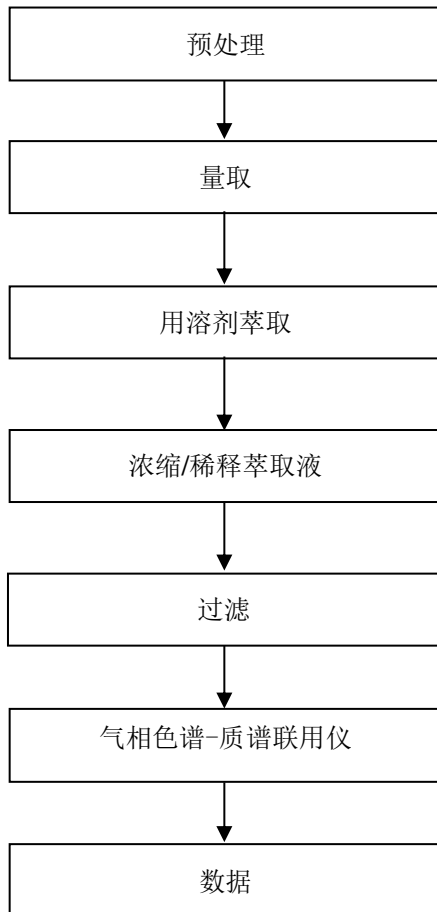

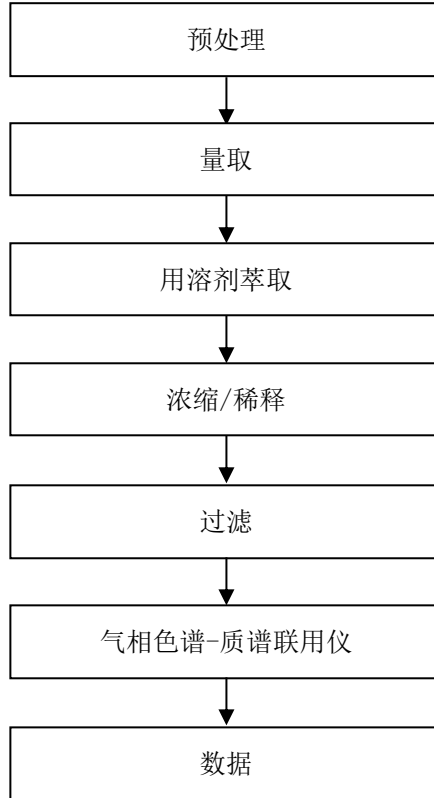

## Phthalates 检测流程图



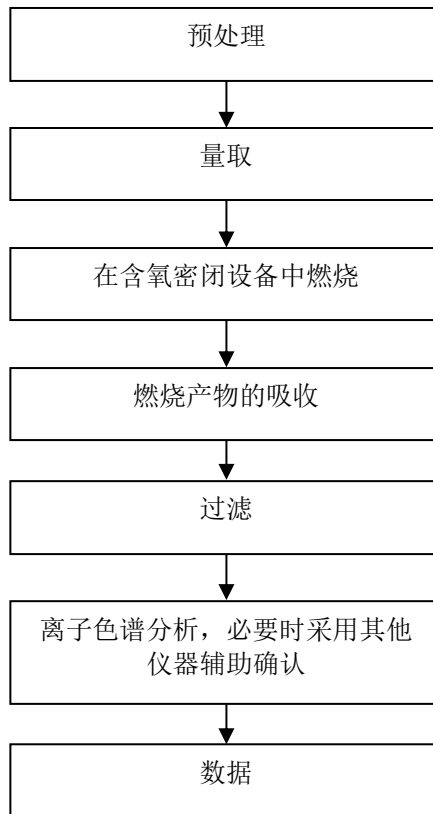

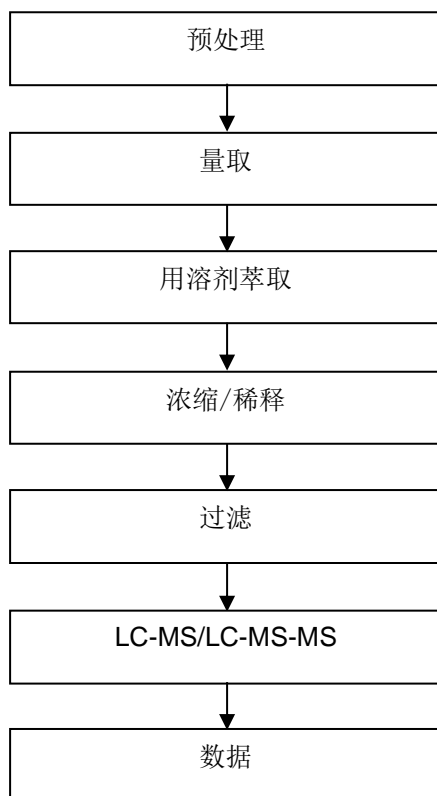
