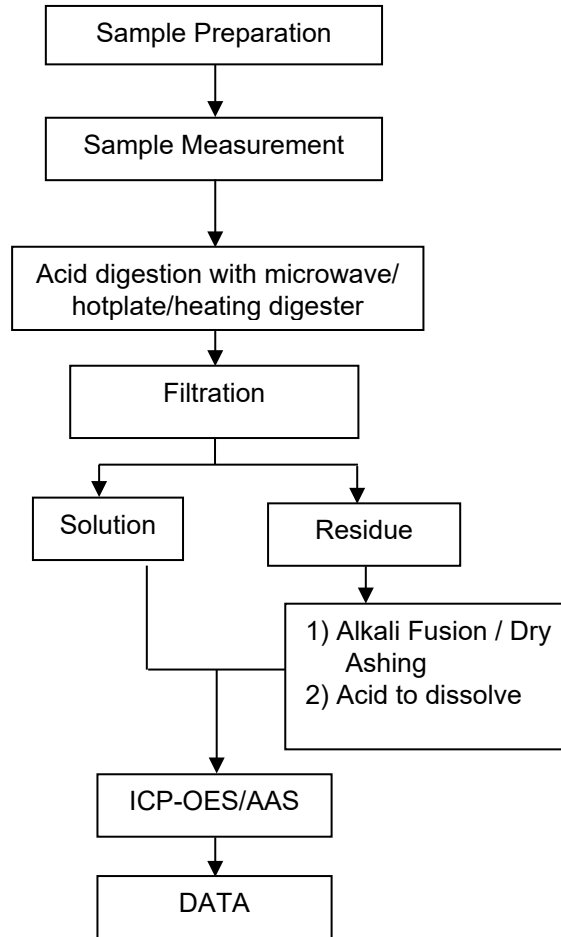

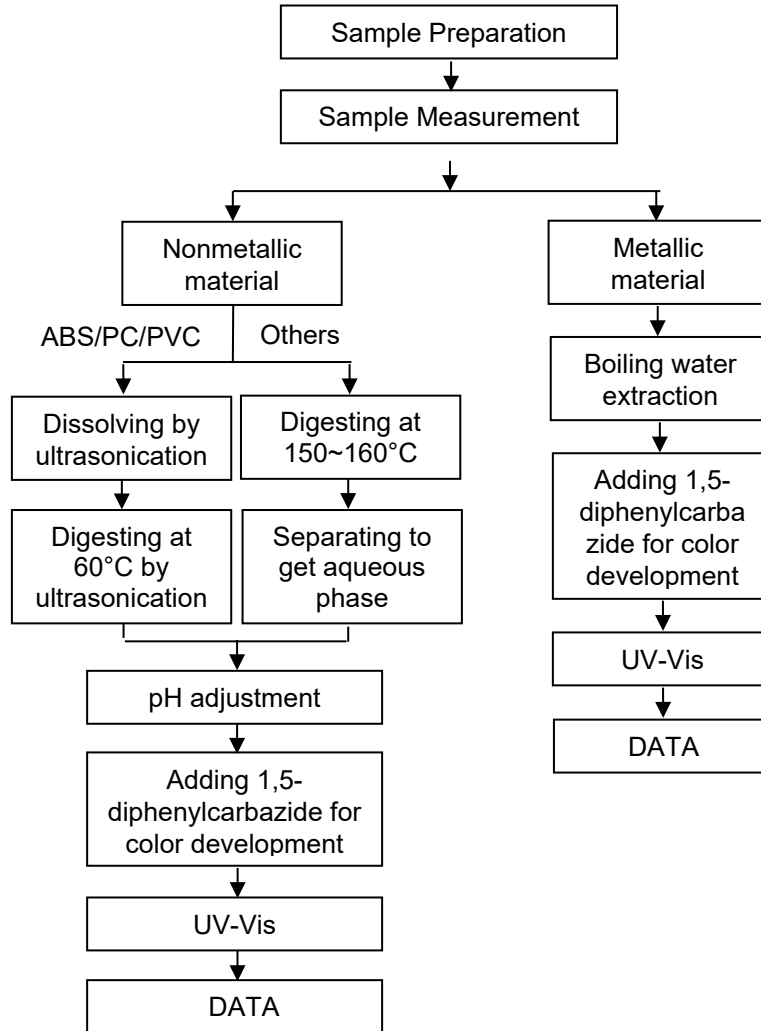

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**



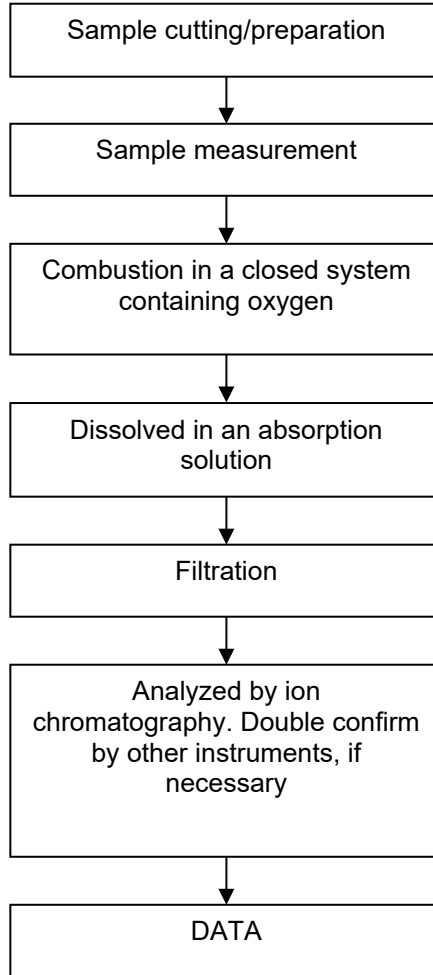

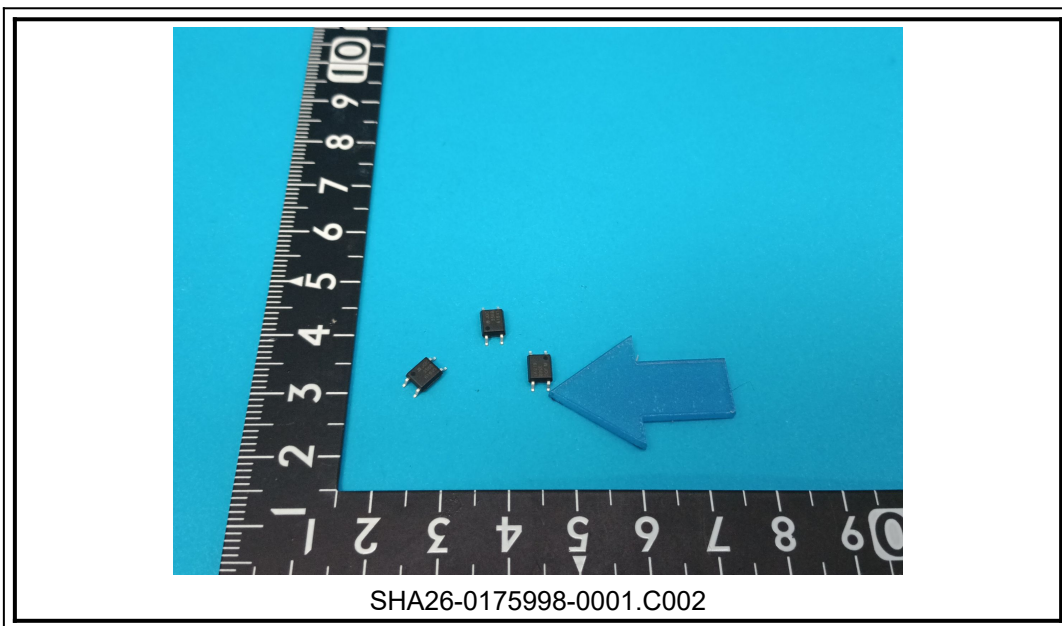
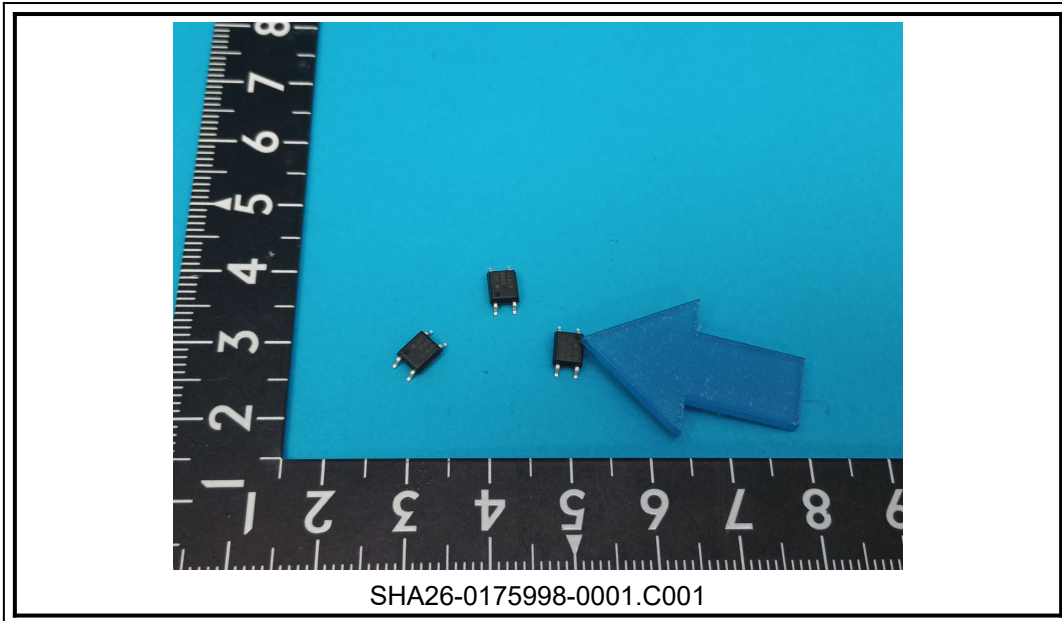
